<sup>&</sup>lt;sup>2</sup> The Independent Inspector is authorized, by its decision, to consolidate two or more than two disciplinary cases conducted on different grounds against one judge into one proceeding. Therefore, the number of received complaints and the number of conclusions may differ.

Regardless of the number of judges indicated in one complaint, the Independent Inspector prepares one conclusion on the basis of one disciplinary complaint and assesses therein the actions of each judge individually. Afterwards, the prepared conclusion is presented to the High Council of Justice of Georgia. The High Council of Justice of Georgia discusses the materials and issues separate decision against each judge. Therefore, the number of the conclusions presented to the High Council of Justice of Georgia and the number of decisions made by the High Council of Justice of Georgia may differ.
